



Herbert O. Haneline Memorial Scholarship

Awarded to a Graduating High School Senior

Herbert O. Haneline, Chairman of the Board of Directors from 1985 – 1989, served on the Board from 1971 through 2002. Herb was an electrician for the City of Fort Wayne, retiring after 27 years. He also retired from the Fort Wayne Fire Department, traffic engineer signal division, and Haneline Electric. He was a Korean War Army Veteran.

This scholarship in the amount of \$1,000 is bestowed annually to a graduating high school senior who exemplifies these values represented by Herb: attitude, academic skills, ability, and active participation in and service to the school and the community. This award will be made to a member in good standing of Fire Police City County Federal Credit Union based on the following criteria:

- Graduation from an accredited high school and entering the initial year of post high school education
- Enrollment in an accredited institution for post high school education or training
- Scholastic achievement
- Involvement in school and community activities
- Essay from applicant
- Letter of recommendation

Application

The following data must be submitted to the Scholarship Committee and mailed or hand delivered to the main office of Fire Police City County Federal Credit Union, ATTENTION: Scholarship Committee, 3306 North Clinton Street, Fort Wayne, Indiana 46805. **Applications must be received by 5:00 p.m. on March 17, 2017.**

1. Pages one through seven of the completed application
2. Applicant's Essay
3. Letter of Recommendation from applicant's teacher or employer.

Selection of the recipient will be made in late March. The scholarship check will be made payable to the student and the attending college, university, or vocational school as soon as the recipient notifies us of the selected school. The funds must be dispersed by September 1, 2017 or will be forfeited. Selections will be made by an impartial committee appointed by the Board of Directors. Employees of Fire Police City County Federal Credit Union, their immediate family, or those living in the same household are not eligible.
