## Read on for important information about your accounts!



# What is changing, what you need to do, and when you need to do it:

- Your debit card is changing! You should receive your new card during the week of September 19, 2022. When you receive the new card you can activate it so it's ready, but you will not be able to use it until October 2<sup>nd</sup> at midnight. Activation will require that you call from a phone number on your account. Please make sure we have your most up to date information! Your City Trust FCU debit card will continue to work over the merger weekend, but from Friday, September 30<sup>th</sup> at 4:00 am through Monday, October 3<sup>rd</sup> at 4:00 am your card will have lower limits than usual as we work to move your accounts over. If you anticipate large purchases or cash needs over the merger weekend, we highly recommend planning in advance.
- Your member number is changing! Your new number will be based on your current member number. Your member number will now be 9 digits long, and you will add a 9 and 0's to your current number to get to 9 digits. Here's a handy chart to show you how to find your new number:

If your current member number is:	Your new member number will be:
1234	900001234
12345	900012345
123456	900123456
1234567	901234567

- Your direct deposits will automatically transfer over. On your first payday, please verify that everything looks right, and if you have any questions, reach out!
- Automatic transfers are changing. If you have an automatic loan payment or transfer set up, here's how it will work after the transition:
  - Any transfers will take place at approximately 12:01 am on the day they are scheduled. We know this is a change, and we're here to help you navigate it! Give us a call after the merger is complete, and we can make sure your transfers are set up to meet your needs.
- **Suffixes are changing**. In this packet is a chart of what Fire Police City County FCU's account suffixes are. For your particular suffixes, simply log into online banking after the merger and you will be able to see them. You can also stop in or call us and we'd be happy to give you the information.
- Fire Police City County FCU members have multiple options for overdraft protection and services. For full details of our overdraft options, including our default coverages, please refer to our membership agreement (available at <u>https://www.fpccfcu.org/resources/merger</u>). You may reach out to us any time after October 1<sup>st</sup> to adjust your preferences.



## **Next Steps:**

- The first time you reach out to us, we'll ask you some extra identifying questions for your security. Once we have you verified, we'll help you set up a verbal account password. This allows us to quickly ensure your account safety every time you speak with us.
- Your MICR number (checking account number) will change slightly and a new membership card will be mailed to you. All existing ACH deposits and withdrawals will work with your City Trust FCU routing and account numbers. Any new ACH that you set up will need to use the Fire Police City County FCU routing number of 274973196.
- Members who do not utilize online banking statements or have a Fire Police City County FCU Visa card are subject to a \$5 per month paper statement fee. We know this is a change and want to make sure you have time to avoid the fee. For assistance with online or mobile banking, feel free to give us a call or stop in. We will be glad to walk you through the process.
- Make sure to review our Fee Schedule so you are familiar with how your Fire Police City County FCU accounts work. You'll also find our most current rate schedule as of August 2022.
