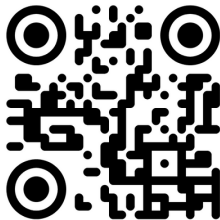

Enter your routing number, CU name: FPCCFCU, and account number that you would like your fund returned to. You will also need to type a description of the bills and the amount.

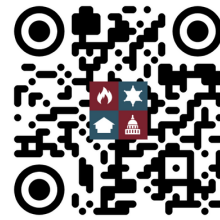
On the next screen, read thru the disclosures, select I agree, and then "Submit".
