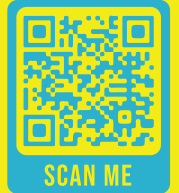

Report of the NOMINATING COMMITTEE

The Nominating Committee has filed the names of the following individuals for the three vacant positions on the Board of Directors. There will be no nominations from the floor. The election of officers will not be conducted by ballot when there is only one nominee for each position to be filled.

Donald Stedje: Mr. Stedje was appointed to the Supervisory Committee in 2004. He also served on the Fort Wayne Police Federal Credit Union Supervisory Committee from 1988-1989, their Board of Directors from 1990 up to the 1997 merger and held the Treasurer and Vice Chairman positions. He was appointed to our Board in January 2009 and serves on the ALCO. He has served as Chairman of the Board since April 2011. Mr. Stedje retired from the Fort Wayne Police Dept. after 20 years of service. After retiring from the Police Department, he was owner operator of Stedje Plumbing & Heating. Mr. Stedje received a Bachelor's Degree in Accounting from Ball State University.

Ray Aufer: Mr. Aufer was appointed to the Supervisory Committee in 2016. He has worked in various manufacturing facilities including Navistar, Fort Wayne Metals, Premier Corporation Contractor for General Motors, and Karl Schmidt Unisia Inc., the Zollner Pistons Division. He served as the Chairman of the Board of Freedom Financial FCU until its merger with Fire Police City County FCU. Mr. Aufer attended Ivy Tech State College and has served on the Credit Union's Nominating Committee.

Joshua Hartup: Mr. Hartup graduated Indiana University Bloomington with a degree in Criminal Justice and completed the I.U. Cadet/Officer Program. He has served on the Fort Wayne Police Department since 1999 and is a certified instructor. Currently, Mr. Hartup is a Uniform Patrol Sergeant, works on the Emergency Services Team (SWAT) and Peer Support Team. He chairs the annual Guns-N-Hoses Charity Golf Outing and has served on our Board of Directors since 2018.

Petition Deadline: **March 1, 2021**

The Nominating Committee has filed the names of the following individuals for the five vacant positions on the Board of Directors. There will be no nominations from the floor. The election of officers will not be conducted by ballot when there is only one nominee for each position to be filled. For members wishing to be nominated by petition, the procedures are as follows:

1. The Nominee's petition must contain the signatures and printed names of at least 1% of the membership (107 members).
2. Nominations must be accompanied by a brief statement of qualifications, biographical data, and a signed statement from the nominee that he or she is agreeable and will serve if elected.
3. To be considered, the nominee's petition must be received by the Secretary of the Board, at 3306 N. Clinton St. Fort Wayne, IN 46805 by close of business on March 1, 2021. To request an application and valid signature form, please contact Jessica at 260-469-5943.

The limit on annual contributions to an Individual Retirement Account (pretax or Roth or a combination) remains at \$6,000 for 2021 or \$7,000 if you're age 50 or older, the same as in 2020. The last date for 2020 IRA contributions will be **April 15, 2021**.
