Credit union members gather for 90th annual meeting

On May 16, our members and the credit union board of trustees met to highlight the 2023 year and to officially adopt the year's financial statements.

2023 Initiatives included:

- financial education programming to promote financial wellness within the community;
- a website chat feature to offer a convenient online method of contact;
- the addition of two new payment features, Pay Anyone and RISE, to

allow for the easy transfer of funds from one person to another;

- the Equal Access and Community Hero mortgage programs to help members secure financing for a home.

The report of the treasurer noted the credit union grew assets 2.5% to \$182.3 million, and experienced a growth in shares that resulted in a 1.7% increase to \$161.4 million. The credit union also returned \$1.7 million to members in dividends.

Personal loan fraud on the rise

Recently, some of our members have been targeted in a scam attempt for money in their efforts to secure a personal loan. As popularity increases in shopping for personal loans online, please remember fraudsters are everywhere and looking to take advantage of any opportunity they can.

In the circumstances of our members, they were asked to provide their account information and told their loan disbursement would be deposited by check into their accounts. They were further directed to send money to the fraudsters in the form of gift cards. Once their information was sent the scammer told them they would not receive their loans.

Signs of a possible personal loan scam include:

- Unrealistic guarantees for approval - Legitimate lenders require an assessment to determine eligibility.
- Upfront fees and hidden costs
- Pressure to act immediately - Scammers often employ high-pressure tactics to convince people to make quick decisions.
- Asking for money or gift cards - Legitimate lenders do not ask for payment in exchange for a personal loan.
- No state registration - Lenders are required by law to register in the state where they do business.
- Unsafe websites and requests for personal information - Check websites that request your information to make certain they are secure and encrypted. Look for indicators like "https" in the website address and a padlock icon in the browser bar to signal a secure connection.

Another way to save: Debit Card Roundup

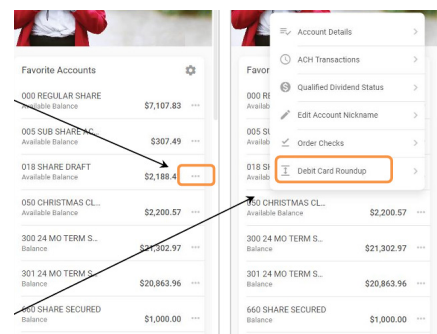
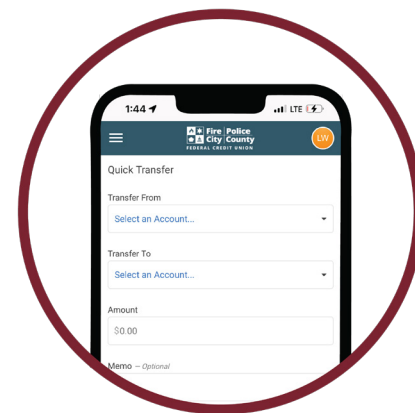
Do you remember saving up your change in a coin jar and cashing it in to make a big purchase or add to your savings?
