Submit Written proposal must include the following to Typed be considered: Proposal - Organization's mission, and an explanation of what your company does - A copy of the companies 501(c)3 - Explanation of how the funds will be used (specific project, new or ongoing, etc.) Answers to the following questions: - Why should the Credit Union choose your organization? - What are your expectations for the event? - Has your organization hosted any fundraising events to raise money for your non-profit? If yes, please explain. - How will your organization help market the Strikes For Charity event? Interview All applicants will be interviewed by the Strikes for Charity committee. Our HR Manager, Kris Gilman, will be reaching out to you after your application is received to set up a specific date and time. After all interviews have been completed, a final decision notification will be sent to all applicants.

#### APPLICATION REQUIREMENTS

- Applicant must be a qualified 501(c)3.

- Applications must be complete, and typed. Handwritten applications will not be accepted.

- Applications should be submitted by September 16, 2022 to HR@fpccfcu.org or mailed to 3306 N. Clinton St. Fort Wayne, IN 46805, addressed to: Attention Kris Gilman.

- Applicant needs to have the ability to promote the event through multiple media avenues: Facebook, Instagram, etc.

- The event must be included in all social media and marketing efforts.

- Event is to be advertised to your Board of Directors, officers, employees, and supporters.

- Provide a minimum of 10 volunteers to work the day of the event.

- Applicants need to secure at least 20 silent auction donations.

- All monthly, bi-weekly, and weekly committee planning meetings that will be held at the Credit Union need to be attended by chosen benefactor of fundraiser.

- All applicants will be interviewed by the Strikes for Charity Committee.
